AC12 Meeting Circular 4 - Meeting location and dates, submission of documents, and applications for Observer status.

As advised in AC12 Meeting Circular 3 (in May 2020), ACAP Parties decided to postpone the AC12 Meeting, originally scheduled for August-September 2020. Following additional intersessional decisions by ACAP Parties and discussions with the chairs and convenors, a decision has been made to hold AC12 as a virtual meeting, in August/September 2021.

Location and Dates

The Twelfth Meeting of ACAP's Advisory Committee (AC12) will be held from 30/31 August to 1/2 September 2021. A detailed schedule will be provided nearer the dates of the meeting, with details of the local time at different locations.

Meetings of the Seabird Bycatch Working Group, and the Population and Conservation Status Working Group will precede AC12: SBWG10 from 16/17 to 18/19 August, and PaCSWG6 from 23/24 to 24/25 August 2021.

Meeting sessions will be no longer than 4 hours per day, to allow for participation across multiple time zones. Online interpretation will be provided. A Heads of Delegation meeting will be convened during the first hour of the Advisory Committee meeting.

Provisional Agenda

Provisional AC12, SBWG10 and PaCSWG6 agendas are attached for your consideration in ATTACHMENT 1. The annotations explain proposed changes to the agenda to take account of the virtual format and reduced hours. Given the reduced time available, we propose that many items be dealt with by correspondence (in advance of the meeting), some through a combination of advanced discussion by correspondence followed by brief discussion at the meeting, and the remainder with more comprehensive discussion at the meeting itself.
