Seventh Meeting of the Parties 17.1 Timing and Venue **AC12 Doc 19** 17.2 Draft provisional agenda MoP Chair, AC Chair, The Seventh Meeting of the Parties will be hosted by Australia and is Secretariat scheduled to be held in Hobart Tasmania in May 2022. Parties have agreed (ACAP ANCP Circular 2021-03) to make a decision by 2 January, based on set criteria, as to whether the meeting can be held in person or will need to be held virtually. A draft provisional agenda for MoP7 is supplied to aid AC with its consideration of potential issues to refer to MoP. Action/expected outcome: Draft provisional agenda agreed. 18. Thirteenth Meeting of the Advisory Committee 18.1 Timing and Venue 18.2 Draft agenda Parties agreed intersessionally (ACAP ANCP Circular 2021-03) to invite Ecuador to host AC13, if it so wishes, because it was not possible to hold AC12 in Ecuador. If Ecuador does not wish to host AC13, offers from other Parties should be sought. A draft agenda for AC13 should be developed by AC Members during AC12. Action/expected outcome: Decision on AC13 venue. Draft agenda agreed. 19. Other Business 20. Adoption of report Report adoption will be by correspondence. Key decisions under each agenda item will be adopted after each agenda item and confirmed before the close of the meeting. A draft AC12 report will be prepared after the meeting and shared with participants for their comments as soon as possible following the meeting. This process will be continued for second (and potentially third) drafts before the report is adopted by correspondence. Action/expected outcome: Key decisions agreed at meeting.
