Birdlife has implemented, together with the 'Albatrosses and Petrels' project and 'Aves Uruguay' an Albatros Task Force (ATF) in Uruguay, and has undertaken ongoing activities with the longline fleet and ports, for the purpose of awareness raising of all stakeholders in the fishing sector and to encourage them to assist with the conservation of these species.
