# **Dates and Venue for AC13 and Working Group Meetings**

As advised in AC13 Circular 1, the Thirteenth Meeting of ACAP's Advisory Committee (AC13) will be held from Monday 22 to Friday 26 May 2023, in Edinburgh, United Kingdom. The venue for the meeting will be **Queen Elizabeth House**, a UK government building located at 1 Sibbald Walk, in the historic Royal Mile area.

Meetings of the Seabird Bycatch Working Group, the Population and Conservation Status Working Group and a joint meeting of both Working Groups will precede AC13 at the same venue.

A Heads of Delegation meeting will be convened on Sunday 21 May in the late afternoon/evening.

#### **Workshop on Bycatch Data**

As endorsed by AC12 (AC12 Report, 14.2) and MoP7 (MoP7 Report, 7.5.6), a one day workshop to discuss bycatch data submission and development of analyses to derive performance indicators will be held on Sunday 14 May. All bycatch data administrators are encouraged to attend, with the workshop also open to interested SBWG attendees.

The workshop will provide an overview of the current ACAP reporting framework, include a practical data entry session, and discuss options for refinement of ACAP seabird bycatch indicators using priority populations and fisheries of interest as case studies. Outputs of the workshop will be presented to SBWG11, under Agenda Item 11 - ACAP Performance Indicators: Seabird Bycatch Data Workshop, for further discussion and consideration. The

workshop draft agenda, together with any relevant documents, will be available on the <u>ACAP website</u> closer to the date.
