# Interim Financial Report

The following interim financial report is provided to the Advisory Committee to provide it with information on the current position of the Agreement's funds. A detailed report has been provided on funds that have been allocated to the Advisory Committee's Work Programme since the Agreement came into force, in order that the Advisory Committee has a complete picture of current allocations, commitments and the funding available for allocation in 2010.

Total funding allocated to the 2010 work programme by MoP3 is AUD \$106,000. Project applications have not yet been called for the 2010 work programme (refer AC5 Doc 30).

The following notes provide additional information on the preparation of the interim report:

Notes re General Fund:

- 1. The income and expenditure statement has been prepared on an accrual accounting basis.
- 2. A list of outstanding contributions from Parties is provided in Annex A.

#### Notes re Special Fund:

- 3. The statement of Special Fund balances has been prepared on a cash accounting basis, covering the period 2005-2009.
- 4. Outstanding commitments include \$100,000 allocated as a contingency fund by MoP2.
- 5. The closing balance of the fund includes \$106,000 allocated by MoP3 to the Advisory Committee's Work Programme for 2010.
