7.3. Proposed Amendment to Annex 1 - listing of *Puffinus mauretanicus* Balearic Shearwater

In accordance with Article XII of the Agreement, Spain has proposed the inclusion of the Balearic shearwater in Annex 1 of the Agreement. The Advisory Committee endorsed this nomination at its sixth meeting (AC6).

7.4. Identification of Priority Actions for Conservation Measures

The Advisory Committee has recently completed and approved a systematic framework that combines information on vulnerability of seabird populations, threats to them and the likelihood of success of addressing threats to derive a set of high priority conservation actions for both land-based and at-sea threats.

Outcome: Note the recommendations made with regard to the prioritisation framework and agree to use the results of the framework to guide the future work of ACAP and Parties and to prioritise actions to achieve the objectives of the Agreement.

7.5. Proposed Indicators to Measure the Success of the Agreement

The Advisory Committee (AC6) reviewed a number of papers and advice relating to indicators, taking account of the conclusions and advice of its working groups on this topic. It recommended that a number of indicators be employed immediately to measure the success of the Agreement, while others are further developed and evaluated.

Outcome: Approval by Parties for the use and further development of the proposed set of indicators recommended by AC6.

7.6. Capacity Building

A definition and set of principles for taking action on capacity building opportunities have been developed by the Advisory Committee and the Secretariat for consideration by MoP.

Outcome: Endorsement by Parties of the recommendations made for the development of capacity building opportunities within the Agreement.

7.7. Development of Arrangements with Other Organisations

MoP3 authorised the Secretariat to enter into a number of Memoranda of Understanding (MoU) with other organisations. Parties

MoP3 established an ad hoc committee to consider options for amending the Scale of Contributions. The result of the ad hoc committee's work outlining preferred options for a revised scale of contributions is submitted for consideration by the Parties.
